

• Naziv projekta i akronim	Enabling Development of Sustainable Cross-Border Clusters - CBC Clusters
• Opis projekta, uključujući njegove ciljeve, rezultate, ishode, aktivnosti itd	<p>Glavni izazov koji će se zajednički rešiti ovim projektom je nedostatak kvalifikovane radne snage za mala i srednja preduzeća u dominantnim industrijama u posmatranoj oblasti - industriji papira i mašinstva u Belišću i poljoprivredi u Somboru, zajedno sa visokom stopom nezaposlenosti i malim potencijalom za inovacije. To će biti učinjeno stvaranjem dva zajednička prekogranična klastera: jednog u sektoru poljoprivrede i primene novih tehnologija u poljoprivredi, koji će se nalaziti u gradu Somboru, i drugog u sektoru papirne industrije i mašinstva, koji će se nalaziti u gradu Belišću. Budući da je glavni cilj ovog projekta stvaranje povoljnog poslovnog okruženja za rast sposobnosti i razvoj potencijala zapošljavanja u okviru malih i srednjih preduzeća, glavna promena koju će on doneti je jačanje prekogranične saradnje između industrije, vlade, univerziteta i civilnog društva uspostavljanjem dva zajednička prekogranična klastera, kojima će koordinirati institucije za podršku poslovanju, na području Sombora i Belišća. Tokom ovog projekta biće uspostavljena dva, već spomenuta, klastera, predstavljeno inovativno mobilno i veb rešenje i razvijen veb alat za mapiranje obnovljivih izvora u poljoprivredi u prekograničnoj regiji. Zajedno sa tim, dve zgrade će biti adaptirane i opremljene za potrebe prekograničnih klastera. Glavna ciljna grupa za ovaj projekat su mala i srednja preduzeća i organizacije za podršku poslovanju, ali i lokalne javne vlasti, univerziteti, interesne grupe i javnost. Ovaj projekat će olakšati i značajno poboljšati saradnju i trgovinski tok između dva područja, omogućavajući malim i srednjim preduzećima da uspostave partnerstvo sa dobavljačima komplementarne ponude i internacionalizuju svoj tržišni assortiman.</p>

<ul style="list-style-type: none"> • Description of the project, including its aims, results, outputs, activities, etc 	<p>The main challenge that will be jointly tackled by this project is the shortage of skilled labour force for SMEs in the dominant industries in the area – paper industry and mechanical engineering in Belišće and agriculture in Sombor, together with high unemployment rates and low potential for innovation. This will be done by the creation of two joint cross-border clusters – one in the sector of agriculture and applied new technology in agriculture, located in the city of Sombor, and another one in the sector of paper industry and mechanical engineering, located in the town of Belišće. Since main objective of this project is creation of favourable business environment for growth of capabilities and employment potential of SMEs, the main change it will bring about is strengthened cross-border industry-government-university-civil society cooperation through the establishment of two joint cross-border clusters, coordinated by business support institutions, in the</p>

	<p>area of Sombor and Belišće. During this project two clusters will be established, innovative mobile and web-based solution will be introduced and web-based tool for mapping of the renewable resources in agriculture in the CBC region will be developed. Together with that, two buildings will be adapted and equipped for cross-border clusters purposes. Main target group for this project are SMEs and business support organisations, but local public authorities, universities, interest groups and general public as well. This project will facilitate and significantly improve the collaboration and trade flow between the two areas allowing SMEs to form partnerships with vendors of complementary offerings and internationalise their market range.</p>
